Incomplete applications will not be processed. Scholarships are awarded for a one-year period. You must submit a new application each year.

Awards are made in early February, and all applicants will be notified promptly. Upon enrollment, a non-refundable deposit equal to one month's tuition, at the scholarship rate, and the annual supply fee, also non-refundable, are due in order to secure your child's position in the class. For new students these payments are due by February 15, 2019. For returning students the supply fee is due February 15, 2019 and the deposit is due May 1, 2019. If a new or returning student is admitted after the respective deadline, these non-refundable payments are due upon admission. Failure to submit the tuition and supply fee payments by the dates listed above will release your child's position.
